** The mandatory comment period for a Proposed Rule is 30 days. The last day of the comment period must also be a working day. The dates in this column reflect these requirements. Subsections 63G-3-301 (11) and (12).

***Statute requires that the Notice of Effective Date must be received by the Office of Administrative Rules on or before the effective date of the rule. Subsection 63G-3-301(12). The office will not accept a Notice of Effective Date prior to the end of the agency-designated comment period. Statute provides that a rule may be made effective "no fewer than seven calendar days after the close of the public comment period ..."

† Statute provides that a rule may be made effective no "more than 120 days after the publication date." Subsection 63G-3-301(12).
